INTRODUCTION

Botswana domesticated SDGs indicators are all the global SDGs indicators that are applicable to Botswana. The indicators are also mapped to the relevant pillar of the Botswana Vision 2036.

The domesticated SDGs indicators are organised into 2 groups according to whether the indicator is measurable globally (Tier I and II) or not yet measurable globally (Tier III). The description of the 3 tiers of the global indicators is as follows;

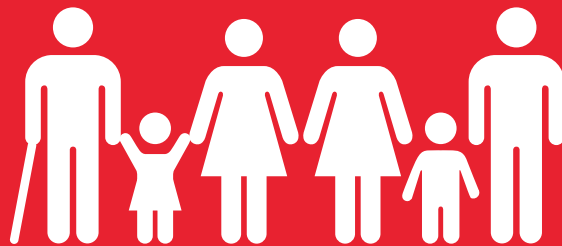
Tier I: indicator is conceptually clear, established methodology and standards are available and data are regularly produced by countries;

Tier II: indicator is conceptually clear, established methodology and standards are available but data are not regularly produced by countries;

Tier III: no established methodology or standards are available for the indicator or methodology/standards are being developed or tested for the indicator.

Goal 1: End poverty in all its forms everywhere

By 2030, end preventable deaths of newborns and children under 5 years of age, with all countries aiming to reduce neonatal mortality to at least as low as 12 per 1,000 live births and under-5 mortality to at least as low as 25 per 1,000 live births

Indicators

- 3.2.1 Under-five mortality rate
- 3.2.2 Neonatal mortality rate

Target 3.3

By 2030, end the epidemics of AIDS, tuberculosis, malaria and neglected tropical diseases and combat hepatitis, water-borne diseases and other communicable diseases

Indicators

- 3.3.1 Number of new HIV infections per 1,000 uninfected population, by sex, age and key populations

Target 3.8

Achieve universal health coverage, including financial risk protection, access to quality essential health-care services and access to safe, effective, quality and affordable essential medicines and vaccines for all

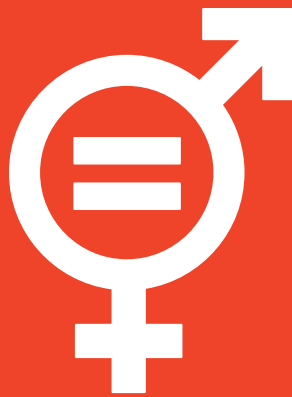
