# **BOTSWANA FOOD IMPORTS** ANUARY 2021

The total value of food imports in January 2021 stood at **P 782,177,619**, representing 10.9 percent of the total imports, with "Sugar & Sugar Confectionery" accounting for 18.7 percent, followed by "Cereals" at 15.3 percent.


"Cane sugar not containing added flavouring" and "Other Cane sugar" and "Beet sugar" made contributions of 55.0 percent, 16.9 percent and 14.8 percent respectively to this group.

"Dried Maize (Corn) kernels or grains fit for human consumption, not further prepared or processed not packaged as seeds"; "wheat and muslin, other than durum wheat other than seed and rice" and "semi-milled or wholly milled, whether or not polished or glazed" made contributions of 49.3 percent, 19.9 percent and 19.4 percent, in that order, to Cereal imports.
