PREFACE

For the first time, Statistics Botswana is releasing the quarterly stats brief for Tourism Statistics. This Quarter 1, 2022 Stats Brief and subsequent ones will not replace the Annual Report, but give a summary of international visitors entering the country on quarterly intervals. The quarterly report will just give the total number of arrivals but discussion will be centered on tourist arrivals. The annual report will continue to be published at the end of each year, giving detailed information on arrivals and departures as well as tourists arrivals for the entire year. During this quarter, Botswana had a handful of border posts in operation.

The statistics contained therein include arrival of visitors and non-visitors by country of residence and other key characteristics. These statistics are compiled from electronic and manual embarkation records completed at gazetted ports of entry into the country and this covers all land borders as well as airports.

The country received a total of 158,284 international tourists during the first quarter of 2022. These represented 90.1 percent of total inbound arrivals, the bulk of which emanated from the SADC sub-region. South Africa contributed 56,742, representing 35.8 percent of overall tourist arrivals. In Transit tourists represented the highest proportion of tourists, at 47.9 percent (75,804) followed by Business tourists at 20.4 percent (32,330), while Holiday tourists accounted for 16.8 percent (26,666) of all the tourist arrivals.

1.0 Total Arrivals

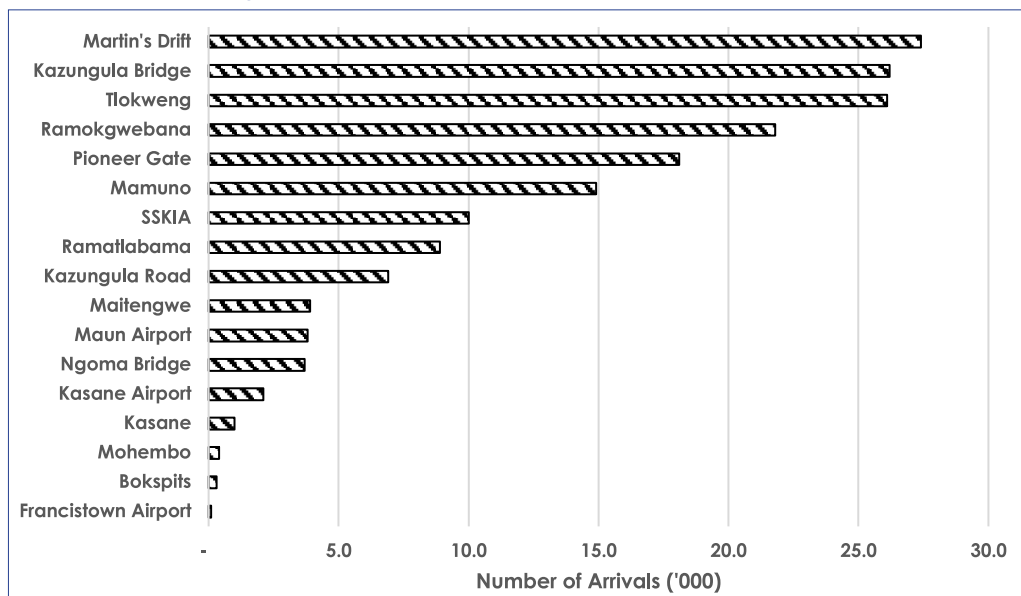
This section deals with all arrivals, including tourists and returning residents but excludes Botswana citizens, for Quarter 1, 2022. Appendix 12 and 13 show that the country received 175,699 arrivals, with March recording the highest number of arrivals at 37.3 percent (65,559).

Appendix 12 presents total arrivals by Purpose of Entry. It shows that most arrivals were those In Transit at 43.1 percent (75,800), followed by those who came for Business at 18.4 percent (32,327). Those who came for Holiday/Leisure accounted for 15.2 percent (26,656), while those who came to Visit Friends and Relatives represented 9.9 percent (17,382) of total arrivals.

1.1 Port of Entry

Figure 1 and **Appendix 2**, show the number of arrivals per port of entry. Most arrivals came by road using Martin's Drift Border Post, at 15.6 percent (27,426), followed by Kazungula Bridge which recorded 14.9 percent (26,194). The least number of arrivals were those who came through Francistown Airport at 0.1 percent (132).

2.0 Visitor Arrivals

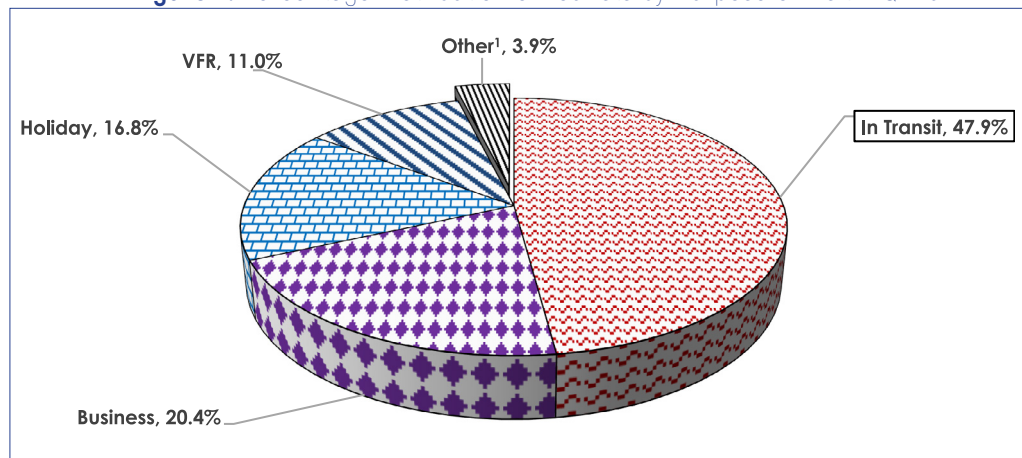
In the first quarter of 2022, the country recorded a total of 175,699 non-citizen arrivals, 90.1 percent (158,284) of these were international visitors (tourists). The majority of these visitor arrivals originated from the SADC region. Appendix 11 shows that most tourists came from South Africa, Zimbabwe and Zambia. These three countries accounted for over three quarters of all tourists, at 35.8 percent (56,742), 21.7 percent (34,366) and 18.2 percent (28,828) respectively.

2.1 Purpose of Visit

Figure 2 and **Appendix 3** show the distribution of tourists by Purpose of Visit. Tourists came into the country for different reasons and this sub-section gives the associated information. Most of the tourists were In-Transit visitors, representing almost half of all tourists, at 47.9 percent (75,804). These were followed by those who came for Business at 20.4 percent (32,330) and Holiday/Leisure at 16.8 percent (26,666). The least number was for those who came for 'Other' purposes, making up 3.9 percent (6,099) of total tourists. Other purposes here, specifically combines shopping, religious, sports and medical reasons.

Appendix 3 further shows that March recorded the highest number of tourists at 38.2 percent (60,514). This was followed by January at 32.7 percent (51,804). The least number of tourists was recorded in February at 29.0 percent (45,966).

Other¹ - Arrivals for shopping, religious activities, conferencing, sports and medical reasons.

2.1.1 Sex Distribution

The sex distribution in **Table 1** and **Figure 3** shows that more males visited Botswana compared to females during this quarter. The proportion of males to females was higher at 80.1 percent (126,828) compared to 19.9 percent (31,456) of females. This disparity is also observed in the purpose of visit by sex. Business and In-Transit tourists indicate the split of 89.3 (28,859) to 10.7 percent (3,471) and 87.6 percent (66,436) to 12.4 percent (9,368) of males to females respectively.

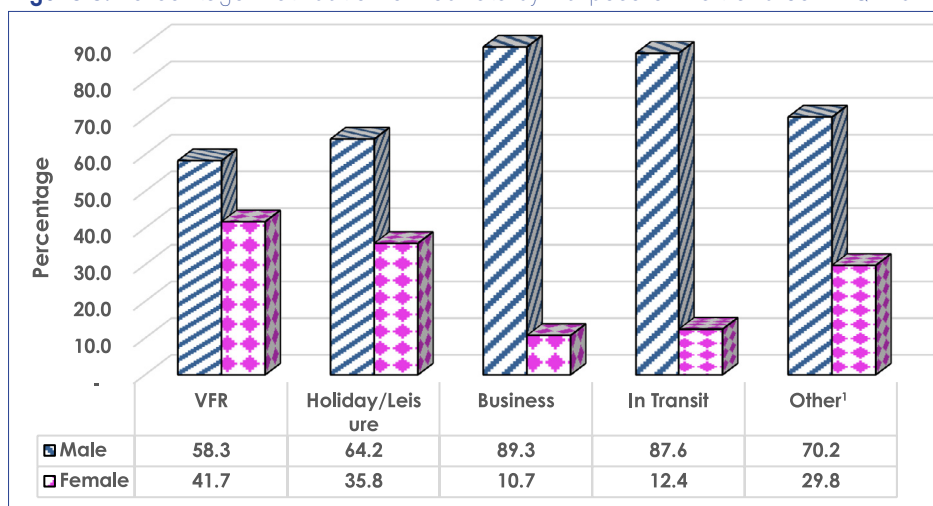

2.1.2 Length of Stay

Table 2 and **Figure 4**, present the length of stay of tourists during this quarter. The majority of tourists spent four to seven (4-7) days at 41.8 percent (66,142) followed by those who spent one to three (1-3) days, accounting for 25.5 percent (40,403).

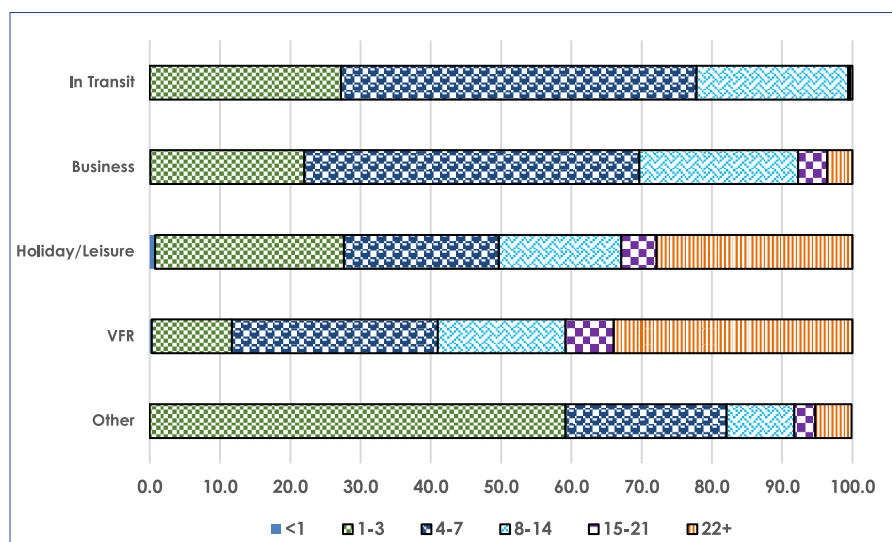
Holiday/leisure tourists accounted for the bulk of visitors who spent more than 21 days at 49.4 percent (7,451), followed by those Visiting Friends and Relatives and those who came for Business purposes at 39.2 percent (5,919) and 7.8 percent (1,176) respectively.

Those who came for Business and In-Transit mainly spent four to seven (4-7) days. Those who came for Holiday and those who came to Visit Friends and Relatives mainly spent more than 21 days while those who came for Other purposes mainly stayed for one to three (1-3) days.

Figure 4: Percentage Distribution of Tourists by Purpose of Visit and Length of Stay – Q1 2022



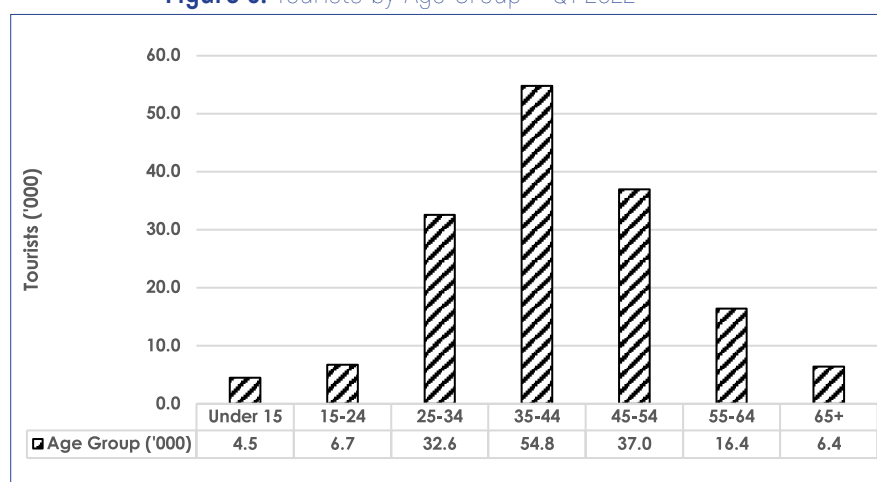
2.1.3 Age group

Figure 5 and **Appendix 7**, present the distribution of tourists by age group. During this quarter, majority of tourists were in the middle ages of 35-44 years, representing 34.6 percent (54,819) of total tourist arrivals (158,284).

The age group 35-44 accounted for 25.6 percent (6,822) of the Holiday/Leisure Tourists, followed by those aged 45-54 at 20.8 percent (5,544). Those aged 15 years and below made up 5.1 percent (1,372) of Holiday/Leisure Tourists.

The combined total of the under 15 years of age tourists for all purposes of visit accounted for 2.8 percent (4,456) of tourist arrivals.

2.2 Key Overseas Countries

The United States of America was the major source of tourists from overseas, refer to **Table 3**. The country supplied 29.5 percent (3,139) of all top ten overseas tourists. This was followed by Germany and the United Kingdom at 20.4 percent (2,177) and 17.9 percent (1,905) in that order. India occupied fourth spot with 7.5 percent (798).

According to **Table 3**, the top ten overseas countries had Holiday/Leisure as the main purpose of visit. Overall, the category represented 65.0 percent (6,924) of the 10,646 tourists from the Top Ten Overseas countries of residence. Business is the second most popular purpose of visit at 13.3 percent (1,413).

Appendix 9 shows a detailed analysis of tourists by country and continent of residence.

2.3 Tourists from Key African Countries

Table 4, based on **Appendix 9** shows tourists by country of residence and purpose of visit from the key African countries. All of these countries are in the SADC sub-region and they accounted for 90.2 percent (142,820) of the total tourists. South Africa comes first with 39.7 percent (56,742). Zimbabwe had the second largest number of tourists amongst the top ten African countries, at 24.1 percent (31,366) followed by Zambia with 20.2 percent (28,828). There were three countries that contributed less than a thousand tourists each. These were eSwatini at 0.7 percent (952), Mozambique with 0.3 percent (490) and the Democratic Republic of Congo at 0.2 percent (336) of tourists from the top 10 African countries.

2.4 Country and Region of Residence

Table 5 shows that most of the source countries are from the African continent. The continent provided 91.5 percent (144,811) tourists, followed by Europe at 4.9 percent (7,812). The least number of tourists were from the Middle East at 0.2 percent (360).

3.0 Technical Notes

This section presents data sources, methodology and definition of terms used in production of tourism statistics. This is meant to enable the users to interpret the statistics carried in this stats brief with understanding of how the data is sourced, how processing and compilation of the report is done and what the various terms used in the report mean.

3.1 Data Source and Methodology

The data used in the production of this report is sourced from administrative records of the Department of Immigration and Citizenship.

International tourist data used in this publication was collected using Arrival forms that were completed by non-citizens at gazetted ports of entry (Land Borders and Airports). Each form asks questions on personal characteristics of the traveler which include among others, sex, age, country of nationality, country of residence and purpose of entry. By default data is also collected on the month of travel, mode of transport and port of entry.

The results and analysis presented in the report follow the guidelines, definitions and classifications recommended by the United Nations World Tourism Organization (UNWTO) and the United Nations Statistical Commission (UNSC). This publication is produced in line with international accepted statistical standards and guidelines.

3.2 Glossary

Traveler- An individual who moves between different geographic locations (in this case country) for any purpose and any duration.

Overseas – All countries and territories outside the continent of Africa

Visitor - Refers to any person travelling to a place other than that of his/her usual environment for less than twelve consecutive months and whose main purpose of the trip is other than the exercise of an activity remunerated from the place visited.

Tourist (Overnight) – An international visitor who stays at least one night in a collective or private accommodation in the country visited.

Same-day visitor – An international visitor who does not spend the night in either a collective or private accommodation in the country visited.

Excursionist – A same-day visitor whose trip does not include an overnight stay (usually for leisure).

Resident – Refers to a non-citizen residing in Botswana on a permanent or temporary basis.

Country of Nationality – A country where citizenship is held.

Non-resident – Refers to a foreigner (excluding resident) entering or departing the country.
