

BOTSWANA FOOD & BEVERAGES IMPORTS

July 2024



Botswana's total imports were valued at **P6, 935.7 million** in July 2024. In this amount, food and beverages imports amounted to P 1, 226.9 million, representing 17.7 percent of total imports. Cereals (Chapter 10) and Beverages, Spirits & Vinegar (Chapter 22) accounted for 17.6 percent and 15.5 percent of food & beverages imports respectively. Preparations of cereals, flour, starch or milk; pastry cooks' products (Chapter 19) followed with a contribution of 9.3 percent.

During the period under review, the most imported types of cereals was Other Maize (corn) accounting for 41.1 percent followed by Semi-milled or wholly milled rice, whether or not polished or glazed with a contribution of 26.2 percent.

Among Beverages, spirits & vinegar, Beer made from malt and Other fermented beverages (for example, cider, perry, mead, sake), mixtures of fermented beverages, mixtures of fermented beverages & non-alcoholic beverages made contributions of 35.7 percent and 22.6 percent to chapter 22 respectively.


