## Botswana Food Imports

June 2023 🚆

During the month of June 2023, Botswana's total imports were valued at **P 6,936,617,287.9**. In this amount, food imports contributed **P1,131,609,542.9**, translating to 16.3 percent. Cereals accounted for 21.0 percent of food imports. Beverages, Spirits & Vinegar and Sugars and Sugar Confectionery followed with 16.4 percent and 9.7 percent respectively.


Within Cereals; maize (corn) excluding seed, were the most imported at 35.6 percent. Other Wheat & muslin and Semi-milled or wholly milled, whether or not polished or glazed followed with 35.5 percent and 19.1 percent respectively.

Among the Cereals; Spirits and Vinegar chapter, the most imported commodities were Beer made from malt and Mineral waters & aerated waters containing added sugar or other sweetening matter, with contributions of 27.9 percent and 23.3 percent respectively. Fermented beverages (for example cider perry) contributed 22.6 percent to this chapter.
