# Preface

This report provides findings of the 2009 decided criminal cases from all Magistrates Courts in Botswana. This is the third report produced by Statistics Botswana, following the 2003 stats brief which was produced in April 2010 and the 2004-2008 report released in June 2012. The production of this report is in response to demands from the Botswana Government, private sector and the public at large, for information relating to crime in Botswana.

The report is based on data obtained from all twenty Magisterial Courts in Botswana. The analysis is only focused on decided criminal cases and as such excludes pending cases. The crime classification used, was adopted from the Irish Crime classification and adapted to Botswana situation. To prepare this report the data went through coding, entry, cleaning and finally, analysis and report writing.

The Report has an Introductory Background followed by discussion of findings and tables. The 2009 Crime Report has some changes as regards to offence classification. For this analysis offence categories were classified using the Irish Crime classifications which are as follows; Homicide, Sexual, Threat to Murder, Dangerous or Negligent Acts, Kidnapping, Robbery, Burglary, Theft & Related Offences, Fraud, Controlled Drugs, Weapons & Explosives, Damage to Property, Public Order & other Social Code, Road & Traffic, Offences Against Government & Justice Procedures and also the category of Offences Not Elsewhere Classified.

I would like to acknowledge and appreciate the contributions of the Administration of Justice, the High Court in Lobatse/Gaborone for providing the Magisterial Criminal Cases Returns and I would also like to extent my appreciation to all the Magistrate Courts in Botswana for their consistency and continuous submission of monthly Criminal Cases forms.

Statistics Botswana intends to improve on timeliness of this report and produce it annually. Comments and feedback on quality and presentation of information are most welcome.

## 1.0 Introduction

This report mainly focuses on decided (completed) criminal cases in Botswana for the year 2009 from all Magistrates Courts in the Country. It is the third report produced by Statistics Botswana relating to different reported criminal occurrences in the country.

Statistics Botswana analyses data from Magisterial Courts on crime. This data is extracted from the High Court records, coded and analyzed by Crime, Civil and Vital Statistics Unit, to produce yearly reports on crime statistics. This report intends to present data on criminal cases recorded by Magisterial Courts in the year 2009.

Magisterial Courts are categorized into two regions,

1. Southern region which consists of Broadhurst, Village, Extension II, Lobatse, Jwaneng, Mochudi, Kanye, Molepolole, Tsabong, and Gantsi Magisterial Courts.

2. Northern region includes Francistown, Selibe- Phikwe, Mahalapye, Serowe, Palapye, Letlhakane, Masunga, Maun and Kasane Magisterial Courts.

The report mainly focuses on decided criminal cases reported at the Magisterial Courts. Some cases may have been given a hearing but still pending due to different reasons and as such are not included in this analysis. Magistrate courts.

Since there are different types of criminal cases reported at the Magisterial Courts, they have been classified into broad categories namely, Homicide, Sexual, Threat to murder/kill, Dangerous or Negligent Acts, Kidnapping, Robbery, Burglary, Theft & related offences, Fraud, Controlled Drugs, Weapons & Explosives, Damage to Property, Public Order & other Social Code, Road & Traffic, Offences Against Government & Justice Procedures and also the category of Offences Not Elsewhere Classified. This broad classification was adopted from the Irish Crime Classification and adapted to Botswana criminal offenses.

A Principal Offence Rule was not applied when analyzing the data instead all offences committed by the accused were recorded; as such the number of accused is likely to be less than offences committed. Principal Offence Rule states that if a person commits more than one offence simultaneously, he will be recorded only for most serious offence and in that case the number of accused will always be equivalent to the number of offenses committed.

Analysis of crime in the country is of great importance for it advises on adequate planning, implementation and monitoring of viable policies and programs to curb crime. Statistics on crime also help government to evaluate trends on societal wellbeing. Furthermore, in this emerging document there are some findings which are worth noting, such as women committed offences relating to homicide, sex, threat to murder, controlled drugs and arms & ammunition.

# 2.0 Findings

# 2.1 Decided Cases by Months

The results show that there were 5,683 decided cases in 2009. It should however be noted that not all decided cases were registered in 2009 but some have been brought forward from previous years and concluded or decided in 2009. The highest proportion of cases was concluded in June 2009 accounting for 10.8 percent of all the decided cases, and the lowest proportion was recorded in December, same year, with 5.3 percent (Chart 1). Francistown Magistrate Court had the highest number of criminal cases completed (800) while the least (63) were completed in Broadhurst Magistrate Court. (See Table A3).





Chart 1: Percentage Distribution of Decided Criminal Cases by Month, 2009

Chart 2 shows the trend of criminal decided cases from 2004 to 2009. It was observed that there is a general upward trend in the number of cases decided, increasing from 4,943 in 2004 to 5,683 in 2009. Table 8 shows that 78.0 percent of the cases were completed within 12 months of registration with the courts.






# 2.2 Accused by Sex

The analysis shows that 94.2 percent of the accused were males, females constituted only 5.8 percent. Most of the males accused were aged between 20 and 39 years, which is 57.0 percent of all the accused. Female participation in criminal acts is low, when compared to their male counterparts, with the highest percentage (1.2 percent) of accused recorded in the age group 25-29. Records show that males debut criminal acts at age less than 15 years, with six (6) of them accused for different crimes ranging from sexual crimes, threat to murder, assault & related offences and also theft & related offenses. This shows that males get involved in criminal activities at an earlier age than females. Among males, those aged 25-29 years constituted the highest percent of the accused with 17.0 percent followed by an age group of 30-34 year olds with 16.3 percent. Likewise, among females, the highest percentage of accused was recorded in age group 25-29 with 1.2 percent followed by age group 30-34 with 1.1 percent. Given this statistics, it is evident that as age increases participation in criminal acts decreases (chart 3).

The results reveal that males, when compared to their female counterparts, are prone to committing criminal offenses and constituted the highest percentage throughout all age groups. (Chart 3)




#### Chart 3: Percentage Distribution of Accused by Sex and Age Group, 2009

# 2.3 Offences Committed

A Principal Offence Rule was not applied when analyzing this data. According to Chart 4 and Table A5, Theft is the most common offence committed. It includes theft of vehicles, stealing from a dwelling or person(s), interfering with postal matter and stealing goods in transit as well as handling stolen property. Theft constituted the highest proportion (22.5 percent) of all offences committed, and 94.0 percent of the accused for such an act were males. These were followed by offences against government, justice and crime organizations (14.2 percent) of which 1.3 percent of such acts were committed by females. About 11.0 percent of criminal offences were threat to murder/kill; assault & related offences and 95.3 percent, of which 0.7 percent was committed by females. Only males were involved in kidnapping cases and they constituted 0.01 percent of all the cases completed or decided by courts in 2009.






# 2.4 Accused by Age

Table 1 shows distribution of offences by age of accused persons. Distribution reveals that youths aged 20-34 were leading in different types of crimes. About 22.9 percent of those involved in homicide were aged 25-29, followed by age group 30-34 with 18.2 percent and then age group 20-24 with 15.1 percent. Among offenders who were accused of sexual offences, 26.6 percent were aged 20 -24 followed by age group 25-29 with 20.4 percent. Of those accused of threat to murder/killand assault, age group 25-29 contributed the highest proportion with 22.6 percent followed by age group 30-34 and 35-39 with 21.4 and 11.8 percent respectively. Accused aged 20-34 contributed high proportions of 56.3, 58.3 and 51.0 percent among those trialed with robbery, burglary and weapon & explosives respectively.

Among the accused aged less than 15 years, four (4) (66.8 percent) were charged with sex offences, one (1) (16.6 percent) was trialed for threat to kill or assault and related offences and one (1) (16.6 percent) was charged with theft.

The trends show that youth participation in criminal activities has decreased from 2004 – 2009 as depicted by Chart 5 below. This might be due to youth programmes that the government has introduced to improve the lives of youths.




#### Chart 5: Percentage Distribution of Accused by Age, 2004-2009

# 2.5 Verdicts

The law states that one is considered innocent of an offence/crime until found/proven guilty by the court(s) of law. In cognizance of the above records of 2009 shows that; of all the 6,713 cases recorded that year, 37.0 percent of the accused were not found guilty and that only 38.0 percent were found guilty. About 20 percent of the cases were withdrawn and the remaining 5.0 percent were given other verdicts such as committed, verdict not taken, cautioned, dismissed in want of prosecution, reserved or verdict not stated. Among males, 38.0 and 37.0 percent of accused were found guilty and not guilty respectively, while 20 percent charges were withdrawn and 5 percent fell under "other" verdicts. About 16.0 percent of females were found guilty, 12.0 percent were not guilty and 7.0 percent charges were withdrawn whereas 65.0 percent were given "Other" verdicts (Chart 6 & Table 7).

# 3.0 Conclusion

The report shows a steady increase in crime between 2004 and 2009. The male youth aged 25 to 34 look to be more susceptible to committing crime. More than half of all perpetrators were males aged between 20 and 34 years. This trend has remained the same between 2004 and 2009. The most common crime committed by this group was theft and related cases followed by offences against government, road traffic offences and sexual offences.

Females show a very low participation rate in criminal activities compared to their male counterparts. Another striking feature was that only 38 per cent of males were found guilty of their crimes while a further 16 per cent of females were found guilty. The reasons for low conviction rates could not be ascertained by this report.
