## **BOTSWANA FOOD IMPORTS** April 2023


Bamount, food imports contributed P1, 081,368,923.1 representing 17.8 percent. Beverages, Spirits & Vinegar and Cereals accounted for 34.6 percent and 12.8 percent of food imports respectively. Preparations of cereals, flour, starch or milk; pastry cooks' products followed with 7.4 percent.

Within the Beverages, Spirits & Vinegar chapter, the most imported commodity were Waters; including mineral and aerated, containing added sugar or other sweetening matter or flavored, accounting for 60.4 percent. Beer made from malt followed with a contribution of 14.0 percent, while Beverages, fermented; (e.g. cider, Perry, mead, sake) made a contribution of 9.3 percent.

Among Cereals; maize (corn), other than seed and wheat and muslin, other than durum wheat, other than seed accounted for 35.7 percent and 28.3 percent in that order to the cereal chapter. Rice, semi-milled or wholly milled, whether or not polished or glazed contributed 23.3 percent.
