## BOTSWANA FOOD & BEVERAGES IMPORTS

April 2024

Botswana's total imports were valued at **P 7,849.4 million** during the month of April 2024. In this amount, food and beverages imports amounted to P 1,122.7 million, representing 14.3 percent of total imports. Beverages, Spirits & Vinegar (Chapter 22) and Cereals (Chapter 10) accounted for 19.8 percent and 16.3 percent of food & beverages imports respectively. Preparations of vegetables, fruit, nuts or other parts of plants (Chapter 20) followed with a contribution of 9.9 percent.

Waters, including mineral waters and aerated waters, containing added sugar or other sweetening matter or flavored and Beer made from malt made contributions of 29.9 percent and 28.6 percent respectively, to chapter 22.


Among Cereals imports, the most prominent commodity was Other Maize (corn) at 56.2 percent followed by Other Wheat and muslin, not Durum Wheat, other than seed with a contribution of 22.8 percent.
