Botswana Food Imports May 2023


Botswana's total imports were valued at P 6,623,013,500.4 during the month of May 2023. In this amount, food imports contributed P 991,316,047.1 representing 15.0 percent. Cereals and Beverages, Spirits & Vinegar accounted for 18.2 percent and 16.0 percent of food imports respectively. Preparations of cereals, flour, starch or milk; pastry cooks' products followed with 9.3 percent.

Within the Cereals chapter; Maize (corn) excluding Seed and Other Wheat and muslin accounted for 40.6 percent and 35.8 percent in that order to the cereal chapter. Semi-milled or wholly milled rice whether or not polished or glazed Rice contributed 16.4 percent.

Among the Beverages, Spirits and Vinegar chapter, the most imported commodities were Beer made from malt and Waters including mineral waters and aerated waters containing added sugar or other sweetening matter or flavoured from malt, with contributions of 33.0 percent and 17.4 percent respectively. Other fermented beverages (for example cider perry) contributed 16.6 percent.
