## Preface

This Stats Brief presents a summary of Transport and Infrastructure Statistics for Quarter 2, 2023. It covers Motor Vehicle Registrations, Rail and Air transport statistics.

A total of 9,174 motor vehicles were registered for the first time in Botswana in Q2 2023, which was a 25.3 percent increase when compared to Q1 2023. From these, 76.4 percent were used motor vehicles while 23.4 and 0.1 percent were brand new and rebuilt respectively. Motor vehicles license renewals were 134,442, an increase of 9.1 percent from the previous quarter

In Q2 2023, a total of 273,537 net tonnes of goods were transported through rail, which was an increase of 7.2 percent compared to the previous quarter. Revenue generated from the transportation of these goods was P49.2 million.

There was a 60.1 percent increase in aircraft movements recorded in Q2 2023, from 12,214 aircraft movements registered in the previous quarter to 19,557. The bulk of these aircraft movements were domestic, at 80.3 percent of the total. A total of 194,604 passenger movements were recorded this quarter, which was a 38.3 percent increase compared to Q1 2023.



## 1. Motor Vehicle Registration

### 1.1 Motor Vehicles Registered for the First Time

A total of 9,174 motor vehicles were registered for the first time in Q2 2023, this was an increase of 25.3 percent when compared to the previous quarter. Passenger cars made up 74.4 percent of motor vehicles on first registration, followed by vans at 9.6 percent. See [Table 1](#) in [Appendix 1](#) and [Figure 1](#) below.

Of the 9,174 motor vehicles which were registered for the first time in Q2 2023, 76.4 percent were used, while 23.4 and 0.1 percent were brand new and rebuilt motor vehicles respectively. Motor vehicles originating from Japan accounted for most of the motor vehicles on first registration, at 66.2 percent of the total. Those from South Africa followed with 24.4 percent. See [Tables 2](#) and [3](#) in [Appendix 1](#).

In Q2 2023, most of the motor vehicles registered for the first time were of Toyota make, constituting 31.3 percent of the total. Mazda and Honda brands followed at 20.5 and 20.3 percent respectively. See [Table 4](#) in [Appendix 1](#).

Thirty-eight point seven percent (38.7%) of motor vehicles on first registration were registered in June, while 33.1 and 28.2 percent were registered in May and April respectively. See [Table 5](#) in [Appendix 1](#).

Most of motor vehicles on first registrations were recorded in Gaborone at 83.7 percent of the total. Francistown followed with 11.2 percent, while Lobatse recorded 6.8 percent. See [Table 6](#) in [Appendix 1](#)

### 1.2 Motor Vehicle License Renewals

Motor vehicle license renewals in Q2 2023 totaled 134,442, an increase of 9.1 percent from the license renewals of the previous quarter. The bulk of motor vehicle license renewals were done in June at 36.8 percent of the total. May and April accounted for 34.9 and 28.3 percent respectively. 
Toyota make motor vehicles license renewals accounted for 44.3 percent of the total. Mazda and Honda motor vehicles licenses followed with 8.4 and 8.0 percent respectively. See [Table 9](#) in [Appendix 1](#).

## 2. Rail Transport

### 2.1 The Volume of Goods Transported Through Rail

The volume of goods transported using rail in Q2 2023 amounted to 273,537 net tons, an increase of 7.2 percent compared to the previous quarter. Botswana total (Imports plus Botswana origin) and Botswana origin (total exports plus local traffic) constituted 83.4 and 54.1 percent of total goods transported respectively. Total exports made up 36.0 percent of the total while total imports and local traffic constituted 29.2 and 18.1 percent respectively. See [Table 10](#) in [Appendix 2](#) and [Figure 2](#).

### 2.2 Revenue Generated from Goods Transported Through Rail

Revenue generated from transportation of goods through rail in Q2 2023 amounted to P49.2 million which was a decrease of 13.1 percent compared to the previous quarter. The revenue generated in May constituted (P17,813 million) which was 36.2 percent of the total for the quarter while April and June accounted for 33.7 and 30.1 percent respectively. 
### 3. Air Transport

#### 3.1 Aircraft Movements

In Q2 2023 a total of 19,557 aircraft movements were recorded, an increase of 60.1 percent from those recorded in the previous quarter. Domestic aircraft movements made up 80.3 percent of the total while international aircraft movement constituted 19.7 percent. See [Table 12](#) in [Appendix 3](#).

Scheduled arrivals and departures constituted 30.4 and 30.3 percent of total international aircraft movements. In domestic movements, non-scheduled arrivals and departures made up 43.6 and 43.4 percent of total domestic movements. Scenic movements constituted 5.9 percent of the total domestic movements. **Figure 3: Aircraft Movements (Percentage Distribution) by Type of Flight, Q2 2023**




Maun airport registered 68.2 percent of total aircraft movements. Kasane and Sir Seretse Khama International airports followed with 16.2 and 13.3 percent respectively. See [Table 14](#) in [Appendix 3](#).

#### 3.2 Air Passenger Movements

A total of 194,604 air passenger movements was recorded in Q2 2023, an increase of 38.3 percent from the number recorded in the previous quarter. International passenger movements constituted 52.6 percent while the remaining 47.4 percent were domestic. See [Table 15](#) in [Appendix 3](#).

There were 135,406 scheduled air passenger movements making 69.6 percent of the total. Non-scheduled movements constituted 28.1 percent (54,829 passenger movements), while scenic and private ones made up 1.7 and 0.7 percent of the total respectively. Most of the scheduled air passenger movements were recorded at Sir Seretse Khama International airport with 58.3 percent. Maun airport recorded the highest number of non-scheduled passenger movements with 68.9 percent. Only two airports registered scenic flights, namely Maun and Kasane airports. Maun recorded 95.2 percent of total scenic passenger movements. See **Table 17** in **Appendix 3**.

## Explanatory Notes

### 1. Motor Vehicle Registrations

Motor vehicle registration deals with licensing of motor vehicles with respect to those registered for the first time and license renewal of pre-existing ones. First registrations are done at the Department of Road Transport and Safety (DRTS) only, while license renewals are done at DRTS offices, Post Offices country wide and some stores like Sefalana Cash and Carry. First Registration could be new, used or rebuilt.

### 2. Rail Transport

Rail Transport covers passengers and goods transported by rail and the revenue generated from the conveyance of these goods and passengers. Botswana Origin is comprised of Total Exports and Local Traffic goods while Botswana Total is an addition of Total Imports and Botswana Origin goods. Total Traffic is made up of Total Exports, Total Imports, Local Traffic and Transit Traffic. Local traffic is goods transported within Botswana and Transit Traffic is goods transported through Botswana to other countries.


### 3. Air Transport

Air transport section covers the movement of aircrafts and air passengers both locally and internationally.

International movements refer to movements made by aircrafts and passengers to destinations outside Botswana whilst domestic movements account for travels made within Botswana. The movements are further categorized into scheduled, non-scheduled and private.

Scheduled aircraft movements refer to commercial airlines operating on a time table while non-scheduled aircraft movements refer to commercial aircrafts which operate as and when needed. Private aircraft movements refer to non-commercial individual aircrafts. Scenic aircraft movements refer to airlines that focus on wildlife and surrounding natures.
